


## Q1 Overall, do you have a positive or negative impression of the Greenville Independent School District?



## Q2 Would you say that you vote in all, most, only some, very few, or none of the local elections dealing with bond issues, taxes and local development projects?











## Q7 Would you vote for or against the issuance of \$4.5 million in bonds for the construction of an Ag Barn?



## Q8 Do you think the district needs more schools and classrooms to accommodate growth over the next five years, or do you think it has enough?











































## Q29 Which one of the following best describes your opinion about the district rebuilding or replacing older campuses such as L.P. Waters or Greenville Middle School?



## Q30 Do you have any children who currently attend GISD schools?



### Q31 Please describe your relationship with GISD (you may select more than one answer).


