


## TIA Expansion and Modification



### WHAT IS TIA?



The Teacher Incentive Allotment (TIA), allows districts to identify and designate high performing teachers based on student growth and classroom observation. This is an opportunity to recruit, retain, and reward outstanding teachers. Greenville ISD has an approved Local Designation (application) for Cohort F.

#### CURRENT ELIGIBLE TEACHERS



#### GISD's Local Designation System for Cohort F includes:

- Circle: Reading (Pre-K)
- NWEA Map: Reading (K-3)
- STAAR: Reading, Math, Science, and Social Studies
- EOC: Algebra I, Biology, English I, English II, and U.S. History
- CTE Exams that lead to a certification
  (Only those who teach CTE courses that were listed on the April 2023 application)

The goal is to have all GISD teachers eligible to earn a designation.

#### **APPLICATION EFFORTS**



- •We have had 3 TIA Steering Committee meetings towards this effort made up of central and campus level staff that included input from: central and campus level administrators, counselors, support teachers, specials/elective teachers, CTE teachers, SpEd and GenEd classroom teachers.
- •A list of possible teaching positions to be added to the GISD Local Designation System (application) was created.
- •The TIA Committee decided GISD has the capacity to manage 2 Student Growth Measures for the GISD teachers. They will either be scored using Pre-Test/Post Test or Portfolios with rubrics, depending on their teaching assignment(s) to measure student growth.
- •With the Board of Trustees approval, the Grant Manager will move forward with submitting a Teacher Incentive Allotment Expansion and Modification application on behalf of Greenville ISD to include all GISD 087 teaching positions by the application due date, April 15, 2024.
