FEDERAL REVIEWS

The U. S. Dept. of Human Services or Office of Head Start conducted a Focus Area 1 Audit during the 2018-19 school year.

The audit focused on the Head Start Program
Performance Standards in the areas of Program Design
and Management, Quality Education and Child
Development Program Services, Quality Health Program
Services, Quality Family and Community Engagement,
Effective Eligibility, Recruitment, Selection, Enrollment,
and Attendance Strategies, and Fiscal Infrastructure.

The process involved a 5-day extensive audit involving the Director, Coordinators, Head Start Parents, Policy Council Members, Executive Director and the Chief Financial Officer in conjunction with the Federal Auditor.

There were no areas of concern, non-compliance, or deficiency found. The strengthening parent and parent-child supports was noted as a program highlight.





ANNUAL FINANCIAL AUDIT

Greenville Independent School District Financial Office has an independent auditor review all Head Start finances yearly to ensure compliance with Head Start regulations as required by state policy. Our most recent audit shows no area of finings.

EARLY CHILDHOOD DEVELOPMENT & HEALTH SERVICES

- 161 children received Head Start services during the 2018-2019 school year. These children participated in developmentally appropriate activities in a preschool classroom setting.
- 36 children with a diagnosed disability were served. Each child identified with a disability was given an individualized education program (IEP), developed by specialists and parents. Each child's IEP was customized to meet the child's special needs. Progress reports were sent home at the end of each reporting period.

• 161 children were up-to-date (all) on a schedule of age appropriate preventive and primary healthcare, including all immunizations and physical exams. 155 of children enrolled in the program received medical and dental exams.

PROGRAM DESIGN AND MANAGEMENT

- The total budget for the 2018-19 school year \$1,125,538 approved by the Administration for Children and Families. These funds provided Head Start services to 161 children and their families in Hunt County (this number exceeds funded enrollment slots). Hunt County Head Start also met the non-federal share requirement of \$284,957.
- 21 is the number of years that Hunt County Head Start has been providing a comprehensive and high quality program to low-income children and their families.
- 7 parents and community members served on the Policy Council for the 2018-2019 school year.
 The Policy Council provides parents and to participate in shared decision-making that covers program design and implementation of services.
- CPALLS, Portfolios, and Frog Street
 Press Curriculum are the agency's curriculum
 and assessment tools. These tools are used to
 collect and store information, allowing staff, and
 management to assess student and program
 performance.
- STEM classes weekly at each site extend learning in the area of science, technology, engineering and mathematics for all students.
